## ROOM and AREA RENTAL RATES & PACKAGES:

### BASIC INFORMATION:

Thank you for choosing the Kathleen Price Bryan Family YMCA for your Rental Needs! Rental space is available on selected days throughout the year, but availability can change based on the needs of the facility. Internal YMCA programming takes precedence over Rentals.

A deposit of **\$30** is required for all rentals. Deposits should be paid the same week that the rental arrangement is made, with the balance due on (or before) the day of the event. OVERTIME RATES (equivalent to a full hour) will apply to any group who stays longer than the time stated on the rental agreement.

### RATES & PACKAGES:

#### ACTIVITY ROOM :

The Activity Room can accommodate up to 75 persons seated. Chairs, Trash Cans (with Liners) and up to 12 Tables are available with rental. Room has easy access to Playground. Perfect for Birthday Parties, Showers, and Meetings. Food and (non-alcoholic) beverages are welcome.

**\$30 per hour (during YMCA operational hours)**

**\$45 per hour (after hours)\***

#### SMALL AEROBICS ROOM :

The small aerobics room is ideal for up to 25 persons standing or moving or 15 persons seated.. 4 tables and 15 chairs are available upon request. No food or beverages are permitted in the Aerobics Studio.

**\$35 per hour (during YMCA operational hours)**

**\$50 per hour (after hours)\***

#### LARGE AEROBICS ROOM :

The large aerobics room is ideal for up to 50 persons standing or moving or 30 persons seated. 6 tables and 30 chairs are available upon request. No food or beverages are permitted in the Aerobics Studio.

**\$50 per hour (during YMCA operational hours)**

**\$65 per hour (after hours)\***

#### BASKETBALL COURT(S):

Each Half-Court contains 3 goals and can be sectioned off for privacy. No food or beverages are permitted in the Basketball Courts.

**\$37.50 per hour (half court)\***

**\$75 per hour (full court)\***

#### SWIMMING POOL:

The Swimming Pool is available for after-hours rentals only and can accommodate up to 40 swimmers at a time. All Swimmers must be 6-years of age or older to participate in an after-hour rental. All swimmers in a group under the age of 18 will be swim-tested prior to entry. 2 Lifeguards will supervise the activity at all times. Food and (non-alcoholic) beverages are welcome on deck, but should be limited to items that do not need to be heated or refrigerated (i.e., no ice cream), and should be kept away from the water.

**\$75 an hour (after hours only)\***

#### BASKETBALL COURT (HALF COURT) + PARTY ROOM PACKAGE:

**\$55 an hour for members**

**\$65 an hour for the general public**

#### (NON-EXCLUSIVE) SWIMMING POOL + PARTY ROOM PACKAGE:

Up to 20 swimming participants. All participants must be 6 years of age or older to participate. Swim Tests mandatory. Offered Saturday and Sunday afternoons only.

**\$40 an hour for members**

**\$55 an hour for the general public**

**\*An additional \$25 cleaning charge is applicable for after hours rentals that involve dining or any complex rearrangement of the respective rental area.**

**RELEASE AND WAIVER OF LEGAL LIABILITY**

**THIS IS YOUR RELEASE AND WAIVER OF LIABILITY** (the "Release"). You individually and/or on behalf of any minor child, release the YMCA of Greensboro, Inc., its officers, directors, board members, employees, volunteers, agents, independent contractors, other participants and/or others acting on its behalf (collectively, "YMCA"). **You agree that this Release is effective immediately.**

**This is important to you and/or any minor children, so do not sign until you have had your questions answered.** You provide this Release freely, and without duress under the following terms:

- 1) **GENERAL RELEASE:** I hereby agree for myself and/or my child and our respective heirs, assigns and legal representatives, to indemnify, defend and hold YMCA and its officers, directors, board members, employees, volunteers, agents, independent contractors and other participants ("Releases") in the program harmless from any and all claim and causes of action of any nature for any and all personal injury or illness, including death, which may occur to me and/or my child or which may be aggravated during or by any activity during the course of the program in which I have decide to allow myself and/or my child to engage. I further waive any and all claims or causes of action, which I and/or my child may now or hereafter have against Releases which may at any time arise as a result of any act or thing occurring in or arising out of my and/or my child's participation in the program. I further expressly understand and agree the foregoing indemnity, release and waiver is intended to be as broad and inclusive as permitted by the law of the State of North Carolina and that any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.
- 2) **ASSUMPTION OF RISK:** I, individually and/or on behalf of any minor child, expressly and specifically assume any and all risk of injury, illness, death, or property damage resulting from my YMCA activities. **You assume the risks:** I, individually and on behalf of my minor child, understand that YMCA activities are strenuous and dangerous and should be engaged in only by persons in good health. I understand that I should consult a physician before enrolling myself and/or my child in the YMCA program. **Once you sign, you are saying that you understand the risks involved and accept all of the risks.**
- 3) **MEDICAL RELEASE:** I, individually and/or on behalf of any minor child, further hereby release YMCA from any claim whatsoever which may arise as a result of any first aid, treatment, or services or assistance provided to me in connection with any injury that arises from activities at YMCA. **A)** I take full responsibility for my and my child(s) welfare and safety on or at YMCA activities. **B)** I hereby give permission for emergency medical treatment to be administered as deemed appropriate.
- 4) **INSURANCE:** YOU ARE EXPECTED TO HAVE YOUR OWN HEALTH INSURANCE. You should understand that the YMCA does not carry insurance to cover injuries and losses that may befall you.

**ADDITIONAL TERMS**

- 1) **I understand that my rental deposit is non-refundable once paid. I further understand that a function or rental not cancelled by phone prior to the day of the event will still be charged to my YMCA account.**
- 2) **I understand that I am expected to leave the rental area(s) in the same condition that I found them upon entrance, unless otherwise instructed by a YMCA Director or member of the housekeeping staff.**
- 3) **I understand that I must comply with all Bryan Family YMCA policies and procedures while attending my rental function. I am also by extension responsible for the actions of all other children and adults that I bring into the YMCA for the purposes of my rental/function.**

**HAVING READ, UNDERSTOOD, AND AGREED WITH THESE TERMS, I HAVE EXECUTED THIS RELEASE, TO BE EFFECTIVE IMMEDIATELY.**
